Summary	All current University of Phoenix degree students who are actively enrolled in a University of Phoenix bachelor's degree program who (i) have taken a minimum of 24 credits at the University of Phoenix and have at least 18 credits remaining in a University of Phoenix bachelor's degree program; (ii) have an aggregate GPA of 3.75 or higher (on a 4.0 scale) in their current bachelor's degree program; (iii) have not had an unapproved break in attendance greater than 14 days in the last 365 days except for an approved leave of absence as of the scholarship deadline; and apply for this Academic Achievement Bachelor's Scholarship (Current Students) – April 2024 ("Scholarship") prior to the deadline and post attendance in a class between April 1st, 2024 and April 30th, 2024 ("Initial Attendance Window") will have the opportunity to be considered for one of 15 scholarships worth up to a maximum of \$2,000 each, distributed over 20 courses. NOTE: Students must begin the admissions application prior to completing this scholarship application.
Application Deadline	The Scholarship application will be made available online on April 1 st , 2024. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST April 30 th , 2024 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	 Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services. Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient. Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc. Applicant must be currently attending a University of Phoenix bachelor's degree program. Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. Selection Process	 The recipients of the scholarships will be selected by the University of Phoenix. It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. The University of Phoenix accepts no responsibility for incomplete applications, applications not in proper form, lost applications, or any other submission in exception to the instructions.
