Summary	All current University of Phoenix degree students who are actively enrolled in a University of Phoenix master's degree program who (i) have taken a minimum of 9 credits at the University of Phoenix and have at least 9 credits remaining in a University of Phoenix master's degree program; (ii) have an aggregate GPA of 3.85 or higher (on a 4.0 scale) in their current master's degree program; (iii) have not had an unapproved break in attendance greater than 14 days in the last 365 days except for an approved leave of absence as of the scholarship deadline; and apply for this Academic Achievement Master's Scholarship (Current Students) – August 2022 ("Scholarship") prior to the deadline and post attendance in a class between August 1 st , 2022 and August 31 st , 2022 ("Initial Attendance Window") will have the opportunity to be considered for one of fifteen (15) scholarships up to \$2,000 each.

Application Deadline	The Scholarship application will be made available online on August 1 st , 2022. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST August 31 st , 2022 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	 Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services. Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.
	 Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc.
	 Applicant must be currently attending a University of Phoenix master's degree program.

	 5. Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$185 per course until: (i) the student completes 10 courses, after which a final disbursement of \$150 will be applied toward the eleventh course, thus maximizing the \$2,000 total Scholarship amount, or (ii) two years has elapsed from the student's first date of attendance in the their first course, or (iii) the student graduates from their program, whichever comes first. Subsections (i)-(iii) are collectively hereinafter referred to as "Terminating Events". 	
	2. Only the applicants selected as Scholarship recipients will be notified by the University of Phoenix.
