## Academic Achievement (Current Student) Master's Scholarship – December 2023

Section	Description
Summary	All current University of Phoenix degree students who are actively enrolled in a University of Phoenix master's degree program who (i) have taken a minimum of 9 credits at the University of Phoenix and have at least 9 credits remaining in a University of Phoenix master's degree program; (ii) have an aggregate GPA of 3.85 or higher (on a 4.0 scale) in their current master's degree program; (iii) have not had an unapproved break in attendance greater than 14 days in the last 365 days except for an approved leave of absence as of the scholarship deadline; and apply for this Academic Achievement Master's Scholarship (Current Students) – December 2023 ("Scholarship") prior to the deadline and post attendance in a class between December 1 <sup>st</sup> , 2023, and December 31 <sup>st</sup> , 2023 ("Initial Attendance Window") will have the opportunity to be considered for one of fifteen (15) scholarships up to \$2,000 each. <b>NOTE:</b> Students must begin the admissions application prior to completing this scholarship application.

Application Deadline	The Scholarship application will be made available online on December 1 <sup>st</sup> , 2023. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST December 31 <sup>st</sup> , 2023 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	<ol> <li>Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.</li> <li>Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.</li> <li>Applicant must not be an employee (including full- and part-time faculty)</li> </ol>

Selection Process	<ol> <li>The recipients of the scholarships will be selected by the University of Phoenix.</li> </ol>

It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. 	5. The decision of the University of Phoenix is final and not subject to review.
	6. Starting on January 2 <sup>nd</sup> , 2024, the University of Phoenix will begin the selection process for eligible qualified students.
	7. Recipients will be notified no later than February 1 <sup>st</sup> , 2024.

Timing	<ol> <li>The maximum Scholarship award is \$2,000. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$185 per course until: (i) the student completes 10 courses, after which a final disbursement of \$150 will be applied toward the eleventh course, thus maximizing the \$2,000 total Scholarship amount, or (ii) two years has elapsed from the student's first date of attendance in the their first course, or (iii) the student graduates from their program, whichever comes first. Subsections (i)-(iii) are collectively hereinafter referred to as "Terminating Events".</li> </ol>
	2. Only the applicants selected as Scholarship recipients will be notified by the University of Phoenix.
Maintenance Requirements	In order to continue disbursement of the scholarship award, applicant must meet the following maintenance requirements:
	<ol> <li>Applicant must remain in a master's program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their bachelor's or master's program, specific to the original program level award.</li> </ol>
	2. Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses. Any withdrawals or courses not successfully passed in accordance with the program requirements will terminate the scholarship.
	3. Applicant may not have an unapproved attendance gap greater than 35 days.
Terms and Conditions	By applying for a University of Phoenix scholarship and/or accepting the scholarship award, the applicant and/or recipient agrees to the following terms and conditions. 7.	If recipient has applied for or is receiving Title IV financial aid funding, this scholarship may reduce the recipient's eligibility for Title IV financial aid funding to comply with Title IV regulations. In addition, the recipient must maintain continuous attendance as defined by the University of Phoenix and/or must qualify for a leave of absence to maintain his/her financial aid status.
