Summary	All new students or students who have been out of attendance for over 365 days who i) apply for and enroll in a University of Phoenix bachelor's degree program; (ii) have three year's work experience and (iii) apply for this Phoenix Bachelor's Scholarship – August 2023 ("Scholarship") prior to the deadline and register and post attendance in their first class between August 1 st , 2023 and August 31 st , 2023 ("Initial Attendance Window") will receive a scholarship up to \$1,000 each. NOTE: Students must begin the admissions application prior to completing this scholarship application.
Application Deadline	The Scholarship application will be made available online on July 1 st , 2023. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST August 31 st , 2023 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	 Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.
	 Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.
	 Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc.
	 Applicant must apply and be admitted to a University of Phoenix bachelor's degree program.
	 5. Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. Selection Process	 The recipients of the scholarships will be selected by the University of Phoenix.

Scholarship Award Distribution and Timing	The University of Phoenix will determine and notify the recipients of the scholarships upon validation.

The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$50 per course beginning with the student's first attended course and thereafter for those continuously attended courses in their bachelor's program until: (i) the student has maximized the \$1,000 Scholarship amount, or (ii) two years has elapsed from the student's first date of attendance in the their first course, or (iii) the student graduates from their program, whichever comes first. Subsections (i)-(iii) are collectively hereinafter referred to as "Terminating Events".
	2. Only the applicants selected as Scholarship recipients will be notified by the University of Phoenix.
Maintenance Requirements	In order to continue disbursement of the scholarship award, applicant must meet the following maintenance requirements:
	 Applicant must remain in a bachelor's program (all coursework attended must be program applicable courses). Awards will only be

	applied to courses taken as part of their bachelor's program, specific to the original program level award.
	2. Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses. Any withdrawals or courses not successfully passed in accordance with the program requirements will terminate the scholarship.
	 Applicant may not have an unapproved attendance gap greater than 35 days.

6.	The Scholarship will automatically terminate if:
	a. Applicant fails to meet the eligibility requirements
	b. Recipient is Academically Disqualified, Disqualified for
	Admission, Scholastically Disqualified, Scholastically Suspended
	or Expelled as outlined in the University Catalog.
	c. Recipient is out of attendance on an unapproved leave of
	absence for more than 35 days.
	d. Recipient completes their bachelor's degree program.
	e. Receives the maximum scholarship award
	f. 730 days from a recipient's first course.

	If recipient has applied for or is receiving Title IV financial aid funding, this scholarship may reduce the recipient's eligibility for Title IV financial aid funding to comply with Title IV regulations. In addition, the recipient must maintain continuous attendance as defined by the University of Phoenix and/or must qualify for a leave of absence to maintain his/her financial aid status.
