## The Phoenix Doctoral Scholarship – December 2023

Summary	All new students who i) apply for and enroll in a University of Phoenix doctoral degree program and (ii) apply for this Phoenix Doctoral Scholarship – January 2024 ("Scholarship") prior to the deadline and register and post attendance in their first class between December 1 <sup>st</sup> , 2023, and December 31 <sup>st</sup> , 2023 ("Initial Attendance Window") will receive a scholarship up to \$3,000 each.  NOTE: Students must begin the admissions application prior to completing this scholarship application.
Application Deadline	The Scholarship application will be made available online on November 1 <sup>st</sup> , 2023. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST December 31 <sup>st</sup> , 2023 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	<ol> <li>Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.</li> </ol>
	Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.

## 1. The recipients of the scholarships will be selected by the University of Selection Process Phoenix. 2. It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. The University of Phoenix accepts no responsibility for incomplete applications, applications not in proper form, lost applications, or any other submission in exception to the instructions. 3. Scholarship selection shall be made without regard to race, color, religion, sex, sexual orientation, gender identity, age, national origin, disability, veteran status, or any other category protected by federal, state, or local law. 4. The decision of the University of Phoenix is final and not subject to review. 5. Starting on January 2<sup>nd</sup>, 2024, the University of Phoenix will begin the selection process for eligible qualified students. 6. Recipients will be notified no later than February 8<sup>th</sup>, 2024. Scholarship Award The University of Phoenix will determine and notify the recipients of the Distribution and scholarships upon validation. Timing 1. The maximum scholarship award is \$3,000. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$375 per course beginning with the student's first attended course and thereafter for up to eight courses for those continuously attended courses in their doctoral program until: (i) the student has maximized the \$3,000 Scholarship amount, or (ii) two years has elapsed from the student's first date of attendance in the their first course, or (iii) the student graduates from their program, whichever comes first. Subsections (i)-(iii) are collectively hereinafter referred to as "Terminating Events". 2. Only the applicants selected as Scholarship recipients will be notified by the University of Phoenix. In order to continue disbursement of the scholarship award, applicant must Maintenance Requirements meet the following maintenance requirements: 1. Applicant must remain in a doctoral program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their doctoral program, specific to the original program level award.

- Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses. Any withdrawals or courses not successfully passed in accordance with the program requirements will terminate the scholarship.
- 3. Applicant must maintain a cumulative GPA of 3.25 or better for all courses.
- 4. Applicant may not have an unapproved attendance gap greater than 35 days.

## Terms and Conditions

By applying for a University of Phoenix scholarship and/or accepting the scholarship award, the applicant and/or recipient agrees to the following terms and conditions. Failure to abide by any of the following terms and conditions shall result in either disqualification of the scholarship award or termination of the scholarship award.

 All application submissions shall become the property of University of Phoenix, Inc. regardless of applicant being awarded the scholarship. In addition, applicant agrees to execute a University of Phoenix, Inc. Consent and Release Form and further agrees that University of Phoenix, Inc., and its affiliates may release the application and the information contained therein to its agents, contractors and related third parties for the purposes set forth below.

2. Scholarship award is a non-cash award to recipient's University of Phoenix account as outlined on the scholarship application. Scholarship will be applied to the first credit-bearing class with a start date after the award date. No scholarship funds will be applied to previous classes or currently enrolled classes at the time of scholarship award. No check or other cash monies will be disbursed at any time. No exceptions.

The University of Phoenix treats this tuition scholarship, in the form of a non-cash award, as non-taxable income. However, the recipient is encouraged to seek independent counsel from a certified tax consultant

as recipient is responsible for all other costs, liabilities, and obligations including any applicable taxes from the award of this scholarship as Federal laws may change and laws vary from state to state. The University of Phoenix makes no representations with respect to the taxability of this award and the University of Phoenix may change its treatment of the scholarship for tax purposes in its sole discretion.

- 3. This Scholarship may not be combined with any other University of Phoenix scholarship, offers, promotions, memorandums of understanding or other tuition scholarship(s).
- 4. Recipients remain responsible for repayment of all Federal Direct Loans borrowed for your program or any other program you have enrolled in and/or attended are subject to the repayment terms and conditions set forth in the Master Promissory Note (MPN) executed with the U.S. Department of Education.
- 5. This Scholarship is not applicable and will not be issued to:
  - a. Applicants who enroll in a University of Phoenix degree level or program other than what is specifically outlined in the Application's Eligibility Criteria for the scholarship.

  - c. Applicants pursuing stand-alone University of Phoenix certificates.

  - f. University of Phoenix Alumni
  - g. Students who previously started a doctoral program with University of Phoenix
  - h. Applicants receiving any employer benefits or discounts
  - i. Applicants receiving Military Tuition Rate

  - k. Applicants who do not meet the University of Phoenix eligibility requirements
  - I. Students who enroll and start their first course outside the scholarship window.

- 6. The Scholarship will automatically terminate if:
  - a. Applicant fails to meet the eligibility requirements
  - Recipient is Academically Disqualified, Disqualified for Admission, Scholastically Disqualified, Scholastically Suspended or Expelled as outlined in the University Catalog.
  - c. Recipient is out of attendance on an unapproved leave of absence for more than 35 days.
  - d. Recipient completes their doctoral degree program.
  - e. Receives the maximum scholarship award

- f. 730 days from a recipient's first course.
- 7. If recipient has applied for or is receiving Title IV financial aid funding, this scholarship may reduce the recipient's eligibility for Title IV financial aid funding to comply with Title IV regulations. In addition, the recipient must maintain continuous attendance as defined by the University of Phoenix and/or must qualify for a leave of absence to maintain his/her financial aid status. Recipient is required to abide by all state and federal financial aid policies and procedures and all University of Phoenix financial policies and procedures as set forth in the University of Phoenix Academic Catalog, including remaining in good financial standing with University of Phoenix.
- 8. Recipient who falls out of attendance for more than thirty-five (35) days from the last date of academic activity will forfeit his/her scholarship. Recipient who returns from an approved absence will be subject to version and program updates per the University of Phoenix Academic Catalog.
- 9. Should recipient drop, receive a W-grade or otherwise fail to complete a course for which the scholarship, or a portion of the scholarship, has been used to pay the tuition, in no event will any cash refund be given at any time.
- 10. During the term of the scholarship, recipient shall notify University of Phoenix immediately if he/she is convicted of a crime, excluding traffic offenses. Recipient acknowledges that said conviction may impact this scholarship in University of Phoenix's sole discretion.
- 11. Recipient acknowledges and agrees that he/she will not portray University of Phoenix or any affiliates in a negative, harmful, disparaging, offensive or otherwise inappropriate manner as determined in the University of Phoenix's sole discretion.
