Summary	All new students who transfer to the University of Phoenix and who (i) apply for and enroll in a University of Phoenix bachelor's degree program; (ii) have completed and transfer in at least 13 but no more than 60 credits combined transfer credits from accredited institution(s); and (iii) apply for this Transfer Student Bachelor's Scholarship – April 2023 ("Scholarship") prior to the deadline and register and post attendance in their first class between April 1 st , 2023 and April 30 th , 2023 ("Initial Attendance Window") will receive a scholarship up to \$3,000 each. NOTE: Students must begin the admissions application prior to completing this scholarship application.
Application Deadline	The Scholarship application will be made available online on March 1 st , 2023. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST April 30 th , 2023 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	 Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.
	 Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.
	 Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc.
	4. Applicant must not have previously attended University of Phoenix.
	 Applicant must apply and be admitted to a University of Phoenix bachelor's degree program.

	 6. As part of the application, the University of Phoenix will obtain official transcripts from previous institutions. These transcripts will verify the following requirements: a. Must have received a minimum of 13 cumulative credits but no more than 60 credits. b. Transfer students who are new to the University will not be eligible for this Scholarship if they've received more than 60 credits. c. Official transcripts must be received, and the applicant must be officially evaluated and fully admitted into the University of Phoenix by the last date of their first registered course. d. This Scholarship only applies to new transfer students who meet the above criteria.
	 Applicant must post attendance to their first bachelor's degree course within the Initial Attendance Window.
Selection Process	 The recipients of the scholarships will be selected by the University of Phoenix.
	2. 	6. Recipients will be notified no later than June 1 st , 2023.
Scholarship Award Distribution and Timing	The University of Phoenix will determine and notify the recipients of the scholarships upon validation.
	 The maximum scholarship award is \$3,000. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$150 per course beginning with the student's first attended course and thereafter for those continuously attended courses in their bachelor's

	 program until: (i) the student has maximized the \$3,000 Scholarship amount, or (ii) two years has elapsed from the student's first date of attendance in the their first course, or (iii) the student graduates from their program, whichever comes first. Subsections (i)-(iii) are collectively hereinafter referred to as "Terminating Events". 2. Only the applicants selected as Scholarship recipients will be notified by the University of Phoenix.
Maintenance Requirements	In order to continue disbursement of the scholarship award, applicant must meet the following maintenance requirements:
	 Applicant must remain in a bachelor's program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their bachelor's program, specific to the original program level award.
	2. Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses. Any withdrawals or courses not successfully passed in accordance with the program requirements will terminate the scholarship.
	3. Applicant must maintain a cumulative GPA of 3.0 or better for all courses.
	 Applicant may not have an unapproved attendance gap greater than 35 days.
